

## **College of Western Idaho “Canyon County Fair Instagram Sweepstakes” Official Rules**

College of Western Idaho, located at 5500 E. Opportunity Dr, Nampa, ID 83687, is the sponsor for this sweepstakes and hereinafter collectively referred to as CWI or Sweepstakes Provider.

### **SWEEPSTAKES PERIOD**

The College of Western Idaho (CWI) Canyon County Fair Sweepstakes starts on **July 21, 2025, at 10 a.m. Mountain Daylight Time (MDT)** and closes on **July 23, 2025, at 12 p.m. MDT.**
