CONSENT AGENDA

PRESIDENT'S REPORT

Campus Engagement:

- President Jones thanked the faculty, staff and board members for a successful commencement.
- Faculty & Staff Town Hall Meeting was held to share highlights and wrap up the academic year with a Q&A session.
- Following the recent news about the Boise Development, an announcement went out this week regarding the Nampa Campus expansion, which generated multiple media interviews and stories.
- President Jones announced the hiring of Mark Arstein as the Vice President of Advancement. Mark will join CWI beginning June 26, 2023.

Community Engagement:

- University of Idaho has received State Board approval to create a not-for-profit entity to acquire the operations of the University of Phoenix.
- President Jones continues to be diligent in meeting with elected officials and community stakeholders.
- CWI was awarded a \$4.2 million grant through the Idaho Workforce Development Council to support the Advanced Mechatronics Engineering Technology program. This grant was the largest competitive grant CWI has ever received and was possible because so many employees came together as a team.

Bold Achievements:

Executive Director, Audrey Eldridge stated this month's Bold Achievement highlights two competitive CWI Teams:

- The Business Professionals of America (BPA) student organization represented CWI at the 2023 BPA National Leadership Conference last April in Anaheim, California. Eleven students from CWI competed in computer science and business events, and brought home 36 top ten medals, 4 first-place, 5 second-place and 4 third-place plaques.
- The 2023 SkillsUSA Idaho State Leadership and Skills Conference was held April 6, 2023 and hosted at the Nampa Campus Micron Education Center (NMEC). CWI students from various programs participated in both leadership and skills competitions where they brought home 17 medals including 2 bronze, 7 silver and 8 gold. The team will be attending the National Competition in Atlanta, Georgia June 19-23, 2023.

BOARD COMMITTEE REPORTS

COLLEGE RELATIONS

COMMUNICATIONS & MARKETING

Audrey Eldridge, Executive Director, Marketing and Communications

- Paid Digital Advertising impressions were over 17 million, which is triple the amount of impressions compared to last year.
- Call to Action click thru rate (CTR) is at .40% and the industry standard is .1-.2%.
- Applications completed is up + 45% year over year. This is representative of a comprehensive team effort by many departments to rebuild and improve the online application process.
- Website Analytics were reviewed;
 - Page views were 1.3 million, up +3.38%.
 - Unique page views were 1 Million, up +1.08%
 - New Users were 193,000, up +3.71% Year over Year

This is reflective of campaign efforts, marketing investment, as well as website optimization efforts.

- Traditional media outreach includes a comprehensive billboard campaign averaging 1 million impressions weekly. For television and radio there has been 2,600 spots collectively. Also, recently a direct mail postcard promoting summer term was mailed.
- Trustee Bradshaw asked, when applications come in, do we have a question asking how they heard about CWI? Audrey will find this information out for Trustee Bradshaw and report back.
- Chair Lenty suggested Audrey provide a dashboard snapshot of analytics as well as campaign talking points for Trustees to have available to them.

• GOVERNMENT RELATIONS

Ashley Smith, Government & Community Relations Director

- Idaho Launch Event is scheduled for June 29 at the Nampa Micron Educations Center (NMEC). Gov. Little and several legislators will be in attendance.
- CWI is in the News with 856,000 people being reached recently through media interviews, broadcast news stories and 100,000 people alone, through the partnership with the Idaho Steelheads.
- Vice Chair Buckner-Webb asked if the marketing team is able to quantify the responses to the communications being sent out in the community, and if so, how does that look? Director Smith stated the benchmarks reflect the overall uptick and excitement currently happening. With mentions alone showing a 7% increase, there is a lot of excitement and support around CWI right now.

- Director Jensen thanked CapEd Credit Union and Federal Home Loan for awarding CWI a \$34,836 grant. These funds will be used to work with a consulting group to do a Feasibility Study in the community.

 - Director Jensen is expecting 75 people to participate in the VIP Patio, and hoping for a sellout crowd in the stands. A CWI scholarship will be awarded on the field.

STUDENT SUCCESS

Dean of Students, Chad Trisler

- Student Satisfaction Inventory Highlights were reviewed.
- The Educational Experience
 - 88% of Students report being treated with respect by Faculty and Staff.
 - 80% say CWI policies and practices are inclusive and welcoming.
 - 72% rate the quality of instruction they received as Excellent.
- CWI Students Work Hard
 - 53% work full time or more
 - 24% work a second job
 - 27% are primary caregivers for one or more children
- Common Struggles
 - Getting classes in the time and format which fits their life and learning style
 - Limited space for students on-campus outside of the classroom
 - It's difficult to meet people connect and build a community on a multi-campus college.
- CWI Student Satisfaction Report Card
 - 81% said CWI was their first choice
 - 88% of CWI students are satisfied with their college experience
 - 93% say we met their expectations (62% said we exceeded them)
 - 92% said they would still attend CWI if they had the chance to do it all over again.
 - Vice Chair Buckner-Webb asked what percentage of the student body receive scholarship assistance and/or financial aid? Dean Trisler stated most students did not report struggling with getting financial aid. Dean Trisler will look into this and get back to Vice Chair Buckner-Webb.

PROVOST REPORT

Provost, Denise Aberle-Cannata

 Enrollment Update -presented by Assistant Vice President Enrollment and Student Services, Tyler Brown.

- AVP Brown addressed a previous question regarding how many students at CWI receive financial assistance. According to the CWI published "Facts at a Glance", 95% of CWI students receive some form of financial aid.
- Summer Enrollment is up over last year.
- 6,139 applications have been received and we expect another 800+ over the summer.
- Summer "Melt" Retention
 - Keep students engaged between Spring and Fall
 - Regular communication & newsletters
 - Specific outreach based on interest or need
 - Shift to Resource Activities as fall approaches including; Resource Fairs, Campus Tours, Registration Events and week of welcome activities.
- Writing Center Update

 Presented by Gigi Smith, Supervisor, Tutoring Services
 - The Writing Center provides writing support across the institution. For students, it is a bridge between course content and comprehension.
 - Students who receive adequate tutoring support report higher grade point averages, reduced dropout rates and increased retention rates.
 - Asynchronous Consultation Email Service (ACES) is a platform which provides tutoring support on the student's timeline.
 - The number of students helped in the Writing Center has increased by 457%. ACES accounts for 42% of that number.
 - Tutoring Services Leadership acquired CRLA Certification.

Trustee Bradshaw asked if Faculty and Staff have been given the opportunity to provide input into what they would like to see. AVP Miller stated in the programming phase, there was a steering committee as well as program teams made up of Faculty, Staff, and Instruction Leadership, and were able to weigh in on what are the "must haves" and what "would be nice to have".
