EXCEPTIONS TO ADMISSION POLICY

Applicants ages 16

High school students, including home schooled students or other applicants ages 16 may be admitted to CWI once the following conditions are met:

1. One of the following:
 - a. Graduate from high school OR
 - b. Obtain GED
2. Complete the CWI Admission process
3. Complete the Petition for Underage Admission and Parent Consent Form
4. Provide placement to finalize admission
 - a. College Level placement SAT or ACT scores or Math assessment test
 - b. Complete the Write Class placement test

Applicants under the age of 16

Applicants under the age of 16 are not allowed to enroll for classes at CWI. Exceptions are made on a case by case basis by the Assistant Director of Admissions, or other designee, once the following conditions are met:

1. Obtain signature from the local school or district office verifying student is not truant
2. The student must submit a letter describing the reason an exception should be made
3. A parent or guardian must provide a statement supporting the request for an exception
4. Complete requirements 1-5 listed above, under Applicants ages 16

*Applicants under age 18 are not admissible to Cyber security, Fire Service Management, Fire Service Technology, Nursing or Surgical Technology. Please refer to program web pages at <http://cwi.edu/cte> for minimum age requirements.

STUDENT & PARENT ACKNOWLEDGEMENTS & RESPONSIBILITIES

- Courses will be more academically challenging than traditional high school courses
